

Town of Garfield Regular Meeting
Tuesday, September 13, 2022 – 6:30 p.m.
Garfield Town Hall

Chairman Steve Dickinsen called the Regular Meeting of the Town Board of the Town of Garfield to order on Tuesday, September 13, 2022, at 6:30 p.m., in the town hall on Hillcrest Road. Present were Chairman Dickinsen, Second Supervisor Glenn Fremstad, Treasurer Clark Walker, and Clerk Ardy Robertson. Meeting notice verified. Motion to approve agenda made by Dickinsen, seconded by Fremstad, and carried. Also in attendance was Adrian Swanson, Heith Doyle, Alice Glavin and Linda Fremstad. Lamoine Hanson was absent.

Clerk read the minutes of the August 10, 2022 regular meeting. Motion by Dickinsen, seconded by Fremstad, to approve minutes. Motion carried.

Treasurer's report of income and expenses for August, 2022 was presented by Walker. Motion to approve treasurer's report made by Fremstad, seconded by Dickinsen. Motion carried. (ARPA funds of \$72,639.98 are being held in reserve.)

Reconciliation Report presented by Clerk and Treasurer. Motion to accept made by Dickinsen, seconded by Fremstad, and carried. Budget summary report presented.

Clerk presented monthly bills for payment. Motion by Fremstad, seconded by Dickinsen and carried to pay the bills. Motion carried.

Dickinsen discussed road patching material, along with some patching needed on Sperber Road.

Crime Stoppers – A donation is being requested from the town. Motion to make a donation of \$50 made by Dickinsen. Fremstad seconded the motion. Motion carried.

Resident who needs to pay \$500 for road damage has not paid, and clerk will send a reminder.

Clerk will send address updates to WTA, and other town contacts. Our mailing address will be changing to the town hall address which is N12915 West Hillcrest

Road. Adrian Swanson who will be taking over as clerk from Ardy Robertson as of October 13, has purchased and put up a new mailbox at the town hall location.

Whispering Pines ownership is being transferred to Jeremy and Jennifer Skroch, from Douglas Richter. The new owners presented a change of agent form, AT-200, to the board. Motion to acknowledge that we received the AT-200 Appointment of Success Agent – Retail Licenses made by Dickinsen, seconded by Fremstad, and carried.

Discussion on transfer of cash bag from recycling attendant to treasurer.

Discussion on when Alice can work at the recycling center. When she cannot make it, Heith Doyle will work.

Fall workshop will be held in Eau Claire on 9/21 with Swanson, Walker and Hanson attending.



Election training will be held October 4th in Black River Falls from 1-4 p.m., with Swanson, Glavin and Carol Babiak attending. November election will be Tuesday, November 8th.

State convention is coming up in Appleton October 9-11. Swanson will attend, and town will reimburse him.

Motion to adjourn made by Dickinsen, seconded by Fremstad, and carried.
